



## TRAFFIC CONDITIONS

The below tables and maps depict the traffic volumes that currently exist, and what the traffic is modeled to be twenty years in the future.

Level of Service (LOS) is the transportation planning term to describe how good or bad traffic is. The LOS is graded on a scale from "A" being free flowing, no delays to "F" being severe gridlock. The Florida Department of Transportation takes regular traffic counts and is able to use future growth rates based on Future Land Use to model traffic patterns into the future. For this exercise, traffic was modeled twenty years into the future.
